

Eastern Hudson Valley Horse Council Fall Hunter Pace

RELEASE OF LIABILITY

I, the undersigned, (the Rider or Participant) am permitted to participate in or volunteer at **The Eastern Hudson Valley Horse Council Fall Hunter Pace** sponsored and organized by the Eastern Hudson Valley Horse Council (EHVHC) on November 7, 2021 at Tymor Equestrian Center, LaGrangeville, NY. The Rider/Participant and his/her parents or guardian (if Rider/Participant is less than 18 years of age) agree that EHVHC, its officers, directors, agents, members, volunteers and assistants, as well as Tymor Park (collectively the "Releasees") shall not be liable for, and agree to release them from any accident, personal injury, death or property damage that may be sustained by any person or entity, including without limitation the Rider/Participant, as a result in whole or in part from the Rider's/Participant's participation in **The EHVHC Fall Hunter Pace**. This agreement is binding on the Rider/Participant and his/her parents or guardian whether or not said accident, personal injury, death or property damage is due in whole or in part to the negligence of the Releasees. The Rider/Participant and his/her parents or guardian agree to defend and indemnify the Releasees from any claims, demands or suits arising from the Rider's/Participant's participation in The EHVHC Fall Hunter Pace, including without limitation those arising in whole or in part from the negligence of the Releasees.

I understand that equine activities are HIGH RISK activities and involve risks from natural and man-made conditions, including, but not limited to, failure of Rider/Participant to control their horses, the existence of tree branches and roots, animal burrows, erosion, slippery and uneven footing, rocks and other conditions. I agree that natural and man-made conditions are an inherent risk of equestrian activities. I voluntarily assume the risks of encountering these conditions, including without limitation conditions caused in whole or in part by the negligence of the Releasees. I also assume complete responsibility for any injury, accident, or loss incurred to myself, my horse, or my property while a participant in the EHVHC Fall Hunter Pace.

Neither I, nor my representatives, assignees, or heirs, shall make any claim against, maintain an action against, or recover from Eastern Hudson Valley Horse Council, or its members, any property owners over whose land the course is laid or any other organization or persons associated with this event for injury, loss, damage, or death to myself or my property, resulting from my participation. EHVHC reserves the right, at their discretion, to deny participation from their events any Rider/Participant or team that disobeys park rules and regulations, creates a nuisance or jeopardizes the safety, health or comfort of themselves or other participants.

I hereby authorize the EHVHC, its board members, volunteers and agents, the use of any photographs, images, and videos taken in connection with the event for use on the EHVHC website, various social media accounts, and news media.
